4. REGULAR BUSINESS

4.1 BC DAS EXPANSION TO WINE GRAPES: PHASE 1 REPORT & PRESENTATION

Galen Barnhardt of Barn to Bottle Consulting presented the Phase 1 Report and Go/No-go Checklist for expanding the BC Decision Aid System (BC DAS) to the wine grape sector. The report assessed the feasibility of adapting the platform based on industry needs.

Key challenges for wine grape growers include managing pests and diseases (especially powdery mildew, mealybug, and Botrytis bunch rot), climate extremes, and improving irrigation and nutrient timing. Potential barriers to adoption include market demand and value, long-term funding, the need for model validation using BC-specific data, effective weather network coverage, and the availability of suitable models.

The report found strong industry interest in wine grape-specific models and recommends moving forward with model validation, securing funding, and engaging stakeholders for Phase 2.

- Michelle asked about adding private weather stations to improve coverage. Galen noted that while there is
 grower interest, using private stations raises liability concerns. Not all stations are compatible with the
 system, and having one central authority helps ensure proper calibration and reliability.
- Kellie outlined next steps for Phase 2, including developing a project plan, engaging stakeholders, and beta
 testing models. She noted interest from other sectors (e.g., potatoes, blueberries), which could help build a
 stronger case for provincial funding. Madeleine supported this, emphasizing the value of a cross-commodity
 approach.
- Melissa asked whether the 2025 growing season could be used for data validation. Galen confirmed this may
 be possible, depending on researcher availability and the timing of grant funding.

4.2 BC FRUIT WORKS: YEAR 3 FINAL REPORT & PRESENTATION

Shamore presented her final report and reviewed the original goals of the BC Fruit Works (BCFW) project: promoting agricultural jobs to Canadians, connecting growers with workers, and providing HR support for producers. For long-term success, she recommends shifting focus from direct job matching to broader workforce development. This includes raising awareness of industry benefits, improving working conditions, and supporting long-term workforce solutions for both employers and workers.

Key recommendations include:

- Making BCFW an formal initiative under the CCLSP
- · Strengthening partnerships and industry engagement
- Enhancing the website as a central hub for employment-related information
- Delivering targeted workforce and HR support initiatives
- · Advancing a holistic labour strategy through cross-industry collaboration

To implement these recommendations, the industry must be open to shifting perceptions about labour, improving engagement, removing systemic barriers, and ensuring sustained support and resources.

- Madeleine asked whether partnerships with ski resorts or similar organizations helped increase worker
 engagement. Shamore shared that due to a challenging season and lower crop yields, fewer workers sought
 jobs in the Okanagan. Madeleine pointed out that messaging around low crops can have wider impacts on
 recruitment.
- Tyrion asked how to address fragmentation within the industry. Shamore recommended developing a single, coordinated labour strategy that includes both domestic and foreign labour, managed by a consistent team.
 Madeleine agreed, highlighting the need for a unified approach that supports both seasonal and permanent roles.
- Melissa noted that the BCFGA Board has been discussing a pilot project related to foreign labour that would involve collaboration with CCLSP and WALI.

4.3 CROSS-COMMODITY PROJECT DEVELOPMENT AND FUNDING APPLICATIONS

Kellie shared that three new project applications are in progress, focusing on herbicide use, ABAzyne trials for cold and heat mitigation, and the development of an industry data strategy. These proposals will be brought forward for Council review at the next meeting or later in the year.

Kellie provided an overview of the financials for the 2025 Extension Conference. The event brought together professionals from the tree fruit and wine grape sectors to strengthen cross-commodity collaboration and improve extension services. Attendees participated in professional development workshops and worked to align industry priorities for the coming year. The conference wrapped up with a broad discussion where producers, researchers, and consultants shared insights to help guide future extension efforts. CCLSP staff are currently compiling the key takeaways, and a summary report will be shared soon.
